

VIOLET PANTUCCI

Violet Pantucci was born with Lissencephaly. Doctors predicted Violet to develop only to a five-month level, never communicate, make eye contact or have any purposeful movement.

Violet has left the world's best pediatric neurologists speechless as she has progressed and learned to love horseback riding, music, and swimming. Nonetheless, while transporting a toddler can be challenging, getting a soon-to-be twelve-year-old Violet anywhere is becoming more and more difficult. Thankfully, Violet continues to grow like a weed, but every inch and every pound make it increasingly harder for her parents to get her and her wheelchair in and out of a vehicle ill-designed to transport a disabled, soon-to-be teenager.



The cost of the vehicle alone approaches six figures which does not include the continuing cost of larger wheelchairs and other devices needed so that Violet can experience a part of the life she truly deserves, but will have great difficulty finding.

In the words of Violet's mother, Elizabeth, the Pantucci family cannot afford to fear how big a request it might be to seek the financial help of others who doubtlessly feel the pressures of ever increasing costs on their lives. So, while we started this tournament to support continuing training for our investigators, we dedicate this tournament, and a portion of its proceeds, to the Pantucci family, and Violet who deserves to easily get to doctors' appointments, from the Children's Hospital of Philadelphia to Boston Children's Hospital, and to all the therapies, pools, and playgrounds between those destinations.
